





- ·6th Judicial District (Pulaski and Perry Counties)
- $\cdot 9W$  Judicial District (Sevier, Howard, Pike, and Little River Counties)
- ·11W Judicial Districts (Jefferson and Lincoln Counties)
- ·12th Judicial District (Sebastian County)
- $\cdot$ 14th Judicial District (Boone, Marion, Baxter, and Newton Counties)
- ·15th Judicial District (Logon, Scott, Yell Counties)
- ·18W Judicial District (Polk and Montgomery Counties)
- ·20th Judicial District (Faulkner, Searcy, and Van Buren Counties)
- ·21st Judicial District (Crawford County)

We currently have a CoSAR Team representing 49% of the counties in Arkansas and 43% of Arkansas' Judicial Districts.

### **Conference**

The Conference planning committee continues to meet regularly and plan for an in-person conference to be held in September. Given the recent rise in Covid cases, the committee is considering making a backup plan for a virtual conference should Covid related restrictions begin again like last year.

Registration began in June and is limited in accordance with Covid guidance from the Arkansas Department of Health. Covid related precautions will be taken during the live conference.

The conference agenda is complete and approved by the planning committee. Workshop presenters have been chosen and confirmed. The venue has been selected and booked and a hotel contract has been negotiated. There are 46 registrations so far and 20 scholarships for hotel accommodations have been awarded.

# **Prevention Education**



The Prevention program completed its 20-21 school year partnership with the LRPD G.E.M.S and is planning a Primary Prevention training for the mentors of the program over the summer. The program partnered with Carter's Crew, a local nonprofit organization that connects families to community resources and provides emergency assistance as available, to provide an internet safety course for their teens; the training focused on cyberbullying, communicating online, and oversharing.

We coordinated with Netflix and Consent contacts to provide live webinars for statewide partners: "A Social-Emotional Approach to Consent Education" and "Fruit of the Poisonous Tree: How Toxic Masculinity Produces Sexual Assault".

The first meeting to form a state-wide human trafficking advisory council is happening in August. We will discuss possible projects and concerns/questions about the collection of data from participating service providers. A test survey/needs assessment is currently being developed through the collaborative efforts of ACADV, ACASA, and UAMS. We are working to create regional response teams for survivors to provide immediate and long-term services based upon resources in their areas.






